

Green Form: International move of none of the player's biological parents.

If the player is moving to Australia with none of their biological parents for non-football related reasons they will fall under the Green Form.
Click on the Form options below to find out which documents you need.

If the club is professional, we will require an extra document. We will require a letter from the new club stating the status of the new club and the expected duration of the registration.

Green Form 1 A:

The player resided with one parent and now moves to Australia to joining the other parent holding their custody.

Green Form 1 A (i):

The player's custody-holding parent resides in Australia due to employment.

Green Form 1 A (ii):

The player's custody-holding parent resides in Australia for another reason not linked to football.

Green Form 1 A (iii):

The player's custody-holding parent always resided in Australia where the player is now moving.

Green Form 1 B:

The player has always resided with his/her parent(s) in their home country, or the player is returning to his/her home country to live with his/her parent(s).

Green Form 1 B (i):

The player was registered with a club abroad as an 'exchange student' and resided in that country without his/her parents.

Green Form 1 C:

Parental authority taken away from the player's parents and awarded to a third person (legal guardian) by a national authority.

Green Form 1 C (i):

The player follows his/her appointed legal guardian who moves to Australia due to employment.

Green Form 1 C (ii):

The player follows his/her appointed legal guardian who moves to Australia for another reason not linked to football.

Green Form 1 C (iii):

The player joins his/her appointed legal guardian who already resides in Australia.

Green Form 2:

Both the player's parents are deceased and parental authority has been awarded to a third person (Legal Guardian) by a national authority.

Green Form 2 A:

The player follows his/her appointed legal guardian who moves to Australia due to employment.

Green Form 2 B:

The player follows his/her appointed legal guardian who moves to Australia for another reason not linked to football.

Green Form 2 C:

The player joins his/her appointed legal guardian who already resides in Australia.

Green Form 1 A (i):
