

Purple Form: International move of one of the player's biological parents.

If the player is moving to Australia with one of their biological parents for work or other non-football related reasons they will fall under the Purple Form. Click on the Form options below to find out which documents you need.

If the club is professional, we will require an extra document. We will require a letter from the new club stating the status of the new club and the expected duration of the registration.

Purple Form 1:
The parent not moving is still alive.

Purple Form:
The parent not moving is deceased.

Purple Form 1 A:
The player follows his/her custody-holding parent that is moving to Australia for employment.

Purple Form 1 B:
The player follows his/her custody holding parent that is moving to Australia for another reason not linked to football.

Purple Form 2 A:
The player follows his/her parent that is moving to Australia due to employment.
