Guidance Notes

Process:

Providing false or misleading information could result in the immediate cancellation of registration.

This form is to be sent to your relevant Member Federation. The Member Federation must sight all proposed changes in this form and liaise with Football Australia. Once Football Australia has approved the changes and has indicated so in the official section, you will receive confirmation in writing by your Member Federation and the changes will be made to the National Online Registration System.

Club Details:

Insert the name of your Club.

Insert the registration number of your Club (e.g. Incorporated Associations attained via the State or Territory Office of Fair Trading) and the street address, including Suburb, State and Postcode.

Insert Mailing address of your Football Club, including Suburb, State and Postcode.

Insert your Club's email address and telephone number. If your club does not have an email address or telephone number, please provide an alternative (e.g. Club Committee Member's email address or telephone number).

Insert the Member, Zone or District Association of which the Club is a member of (e.g. Central Zone, North Coast Football, etc.)
